It was noted that planning will be the major focus of ASH in the coming year because of the R4 Review Phase 2, re-write of the City of Ottawa Official Plan, development in the neighborhood, etc.

Directors asked to read responsibilities of Directors in the Ontario Not-for-profit Corporations Act.  - Up to \$200.00 for soil and mulch for the Sandy Hill Tree Group June 2 community gardens clean-up. David Elden proposed, Meagan Reilkoff seconded.
 - \$1,400.00 honorarium to be paid to Diane Whalen, Architect, who will represent ASH on the City's Technical Review Committee on the R4 Zoning Review, Phase 2. Chad Rollins proposed, Cathy Major seconded.
